Executive Summary

The rural poor lead deprived lives, bearing the brunt of unequal distribution of natural resources, its mismanagement and non-optimal utilization. These deprivations are not of the highest order, but of the basic necessities Viz. Food, water, and subsequent peace and hope.

SVSS has identified its role in nation-building as that of carrying the message of hope to the underprivileged rural citizens in the form of socio-technical services for natural resource management. Over the 23 years of its existence, our inputs by way of accurate and appropriate solutions have encouraged and empowered them to believe. Our goal has been action on the ground in the service of deprived communities; particularly the poor, marginalized, women, and other neglected sections of society, helping them meet their basic needs by enabling them with necessary capacities to manage Natural Resources in a blend of Judicious practices, aiming at participatory, sustainable, effective and optimal solutions.

The recent Social movements regarding the transparency in work have brought out one clear message- the people have voted for development and a focus on rural livelihoods. The Government of India has responded with the common Minimum programme which reflect a positive change in the central development paradigm, giving due recognition to agricultural and water security needs. Development of macro perspectives on NRM and its promotion through education, and establishment of research and development centers for technology transfer will inject new blood into veins of the interior farmer. Focal areas of work have been identified and cross—cutting issues highlighted, not forced upon from without but arising out of a clearer, understanding of the experience of these within. Annual Review: April 2010 – March 2011

1. Community Action For Justice

Our organization Swami Vivekanand Shiksha Samiti (SVSS) is implementing a project on Access to Justice for marginalized people with the support from Dept. of Justice, GOI and United Nations Development Programme (UNDP). Our project tile is community action for Justice in 44 villages of Sehore District.

Movements call for equitable distribution of resources to build a "Just world". However the way to distribute resources is often through negotiating the resources from those who control resources. Acknowledging that resource distribution between men and women is unequal and will continue to be so unless planned interventions take place The focus is to increasing ownership rights for those who have traditionally been left out of resource management practices due to lack of their ownership and use rights. The key resource that women do not own is land for this reason they have faced destitution and secondary place in governance system.

Women's resource rights are their legal ownership of resources. These are land, housing, & livelihood. To sustain ownership of resources credit, information, Para legal training as well as access to services and amenities is prerequisites. The Project Community Action for Justice(CAJ) have shown a path to make women's land rights a reality, there is a strong need for policy and law reform with gender equal approaches. Similarly strategies to be adopted which aim at creating and ensuring gender equal planning and recognition of women as equal contributors in building economic assets at several levels.

CAJ Project is advocating for a single window approach to women's land, housing and resource rights which locates interventions that increase access to land, livelihood, budgetary allocations, housing and other such resources. These interventions have to be located at the policy and programmatic levels which have implications at local communities' levels.CAJ terms this transformative approach as the Women's Resource Rights Agenda.

The cadre of WSHAG will thus fill very important gap that exists presently. Simultaneously the created cadre will work towards community mobilization by helping the vulnerable women in clearing pending, land claims thus paving way to equal access to common property. Since WSHAGs is part of the existing network of CBOs, they enjoy a relationship of trust and are strategically located to bring `awareness among the women is to disseminate legal awareness effectively and mobilize the marginalized groups to access justice.

The baseline study was conducted in two block of sehore to assess the situation of women on land, housing & resource rights of women and capture practices, problems and experiences on identified issues in the criminal justice process. The random study covering 2000 respondents mainly the women's & FGDs were also conducted gave deep insights of their experiences and the needed



response from the duty bearers across spectrum of revenue, police, legal aid and other supporting actors. The selection of 100 potential WSHAGs members were also done

during the base line survey. During the project period the WSHAGs member will be trained on various legal aspect related to women rights & entitlement to access the justice for weaker section of people and follow up activity will be done at village level by WSHAG members.



2. Celebration of Human Rights Day

World Human Right Day is observed every year across the world on tenth of December to generate mass awareness among the fundamental rights & duties of every citizen of the



country. SVSS as a pro-active organization has always been on the forefront in initiating and promoting advocacy, awareness, and networking and trained the youth of villages on various legal aspects of human rights and create a cadre of volunteer at bottom level. 60 volunteers are trained during the one day orientation programme.

3. Axshya INDIA TB Project

Tuberculosis (TB) is one of the major communicable diseases in developing countries like India, which is proving too hard to be controlled. The disease mainly targets low-income group people who are less healthy and live under unhygienic conditions. Every year T.B. claims nearly 4.17 lakh lives of people, which is serious problem for health sector. India accounts for 1/5th of global incidence of TB and tops the lists of 22 high TB burden countries.

Realizing the seriousness of the issue, Ministry of Health & family Welfare, GOI in support from GFATM (Global Fund against AIDS,TB & Malaria),launched project through Principle Receiptant World Vision & Sub Receiptant Lepra India. The sub-sub recieptant is Swami Vivekanand Shiksha Samiti implementing partner working in Sehore, Raisen district mainly target the rural population, working in close collaboration with DTO.

The project objective were to increase awareness, reduce stigma and ensure peoples participation in Revised National Tuberculosis Control Programme(RNTCP) especially in directly observed treatment short course (DOTS) through IEC intervention and social mobilization, to identify, promote early detection, check the dropout and to strengthen the referral services through the capacity building of CBOs, private practicenors, Aganwadi workers, local leaders, Health service providers and establish the network to a bridge the gap and enhance collaboration among the health providers and health seekers by building the capacity of the Panchayti Raj Intuitions(PRI's) Local Health Functionaries, Village Health & Sanitation Committee Members, Youths etc for patient friendly treatment.

Referral of suspected TB cases through one to one to family contact, orientation of NGO functionaries, Health Service providers, local leaders, orientation of PRI & Ayush practicenors, organizing General Health Camps and community outreach activities, formation of DOTS information cum Counseling Centre and putting Patients on DOTS.

Nearly 4200 individuals and 5300 families were contacted by the volunteers through one to one and one to family contact approach, 1026 suspected cases have been referred to the nearest health facility and 292 positive patients put on DOTS (Directly observed treatment Short Course) and got treatment from the primary Health Centre, Enhanced the collaboration between Health Service Providers and Health Seekers.

4. Celebration Of International Women Day

With the support from Lepra India, the celebration of world women day is celebrated in Sehore, Nasrullaganj & Raisen district with full enthusiasm and zeal. World over, it has

been acknowledged that, violence infringes the human rights of women. Among other things, the state of MP is also known for low social indicators of women, which includes gender based discrimination and violence. From the very beginning, the health of women has always been the core issues of SVSS all intervention. Among the spectrum of issues, it has been realized that without



addressing the issue of violence against women, health of women in totality cannot be achieved.

With this reality in mind, the programme on Gender issues focusing Violence against women was initiated. The programme aims towards" **Creating a Safe Social Space for Women** "A network of Govt. Department, NGOs, Police, ICDS, Legal AID etc has been developed. A cadre of trained manpower and counselors has been developed to carry

forward the message at grass root level. In the campaign nearly 250 participants participated in celebration of world women day.

5. Targeted Intervention for Prevention of STI / HIV Transmission among FSW, MSM in Sehore District

SVSS has undertaken the Targeted Intervention (TI)) project focusing upon Female Sex workers(FSW),Men having sex with Men(MSM) since October 2008. The current year 2010-11 is the third year of implementation of this project.

The project is supported by National AIDS control organization (NACO) under NACP-III. Madhya Pradesh State AIDS control Society is the state level agency to administer the grant and provide regular support. The goal of the project is to contribute in prevention and reversal of the HIV epidemic amongst the FSW, MSM of the Sehore district. SVSS has succeeded in building rapport with the target population and their community. It has succeeded in providing a platform to the targeted community to exchange and share their concerns.

During the project Interventions, SVSS has succeeded in sensitizing the targeted high risk group population over vulnerabilities and risks associated with HIV/AIDS by providing counseling services and quality STI treatments. The HRGs were provided behavior change services related to safer sex practices. During the reporting period FSW MSM spread across locations of Sehore District were provided with the defined services.

6. World AIDS Day Programme

World Aids day is observed every year across the world on first of December to generate mass awareness and keep the hopes alive. This year leadership was chosen as a central theme for World AIDS campaign. This theme will continue to be promoted with the slogan "Stop AIDS-Keep the promise. SVSS as a pro-active organization has always been on the forefront in initiating and promoting advocacy, awareness, networking and decision making to stop AIDS. Advocacy cum exposure visit for the peer educators, FSW, MSM to ICTC, ART centre, Community care centre etc.

With coordination of District legal service Authority orientation programme for MSM/TGS were organized on legal aspects/laws and schemes related with them. The main issue discussed is fundamental rights must be equally enforced in favour of eunuchs and MSM as wells, Identity crisis and recognition in census, Inclusion in voter list and other essential documents, Reservation in line with other Marginalized groups, Civil and legal rights, Decriminalization of same sex relationships and state supported pension plans.

7. Self Help Group Formation and Development

Bringing women together under self-help groups (SHGs) has resulted in their increasing self –reliance and confidence. The idea behind these SHGs is to mobilize women-men and improve their quality of life. A project for women's development with assistance from the National Bank for agriculture and rural Development (NABARD) has been in operation in Nasrullaganj Block of Sehore District since 1st January-2010. This project had used, with commendable success, women's self-help groups (SHGs), supported by SVSS and animators, to mobilize women and bring about self reliance through self-managed group saving fund and improved access to credit so that suitable economic activities could be financed. In these project106 SHGs groups benefiting about1192 Members out of which 8 Men-SHG with 92 members & 98 women SHGs with 1100 members had been organized up to December-2010. The project encourages the beneficiaries in mobilization of savings, utilizing the same according to the priorities of the members of the groups and providing external financial assistance for productive purposes. Providing a range of thrift and credit related services in a viable and sustainable manner is our primary objective and it has led to achievement of various milestones in

the programme. The organization has been successfully in creating an alternative credit delivery system managed by the members.

Given the long –term nature of the issues which negatively impact on women, the overall objective of the project would be to launch a programme which strengthens the processes to promote the social and economic development of women and creates an environment for social change to improve their quality of life.

8. Joint Liability Groups Formation & Access to credit

Facilitating Men —women access to credit to increase their involvement in income generating activities represents the core activity of the project. To this end, savings and credit (with small loans based initially on accumulated savings of the JLG) are the foundation for the JLGs member to build up a record of sound financial management and creditworthiness as the first step in establishing a long-term relationship with lending intuitions.

Started in 2010 with support from National Bank for agriculture and rural Development (NABARD) 30 JLGs already formed in district sehore to promote the provision of services, enabling them in accessing the resources on collective basis with easy access to range of financial services right at their doorsteps.

9. Farmer clubs Promotion Programme

Under the FCP, refine and demonstrate the appropriate transferrable technologies for creating

awareness and motivating farmers to learn and adopt latest production technology options of various agricultural enterprises. Increasing the agriculture productivity, employment generation and ensuring household food and nutritional security at rural level is the priority today. In order to meet these challenges SVSS has been working at Sehore district with 44 FCP in various villages with membership of 528 farmers. The project is supported by



NATIONAL Bank for Agriculture & Rural Development, Madhya Pradesh Regional office.

Farmers are provided financial assistance to organize them in the form of farmers club. One of the main focuses of the revitalized extension system is to provide extension support to a group of farmers rather than to individual farmer. The existing extension system was largely based on agriculture activities and it was top to down, whereas, FCP activities are based on farming system approach with bottom up planning. Under the project we conduct training programmes not only for agriculture but also for allied sectors activities like dairy, fishery,

honey bee; vermin composting etc. A landless farm labour could also get training and can become an entrepreneur in these areas.

Farmers are mobilized into farmers club, which are expected to be federated at block, District and State level as commodity federations/associations. These commodity associations could be linked up with the trade/private sector for organizing demand driven production and supply of agricultural commodities. Farmers club are also motivated for soil testing of their agriculture field. We provide the better agriculture practices are needed to bring sustainability in Indian



agriculture and motivate the farmers for use of organic manure for better agriculture produce and better environment.

10. Capacity Building for Adoption of Technology (CAT):-

The popularization of various technologies were carried out through on – campus at CIAE-Bhopal for the farmer clubs of Sehore .The technologies demonstrated included new variety of crops with package of practices and various important components of the technologies which have high influence on crop productivity such as integrated pest and disease management, integrated weed management and balance fertilization etc.The improved

agricultural machinery with demonstrated. These drills, planters, high machineries like roto-till power weeders, reapers, cleaner- graders. These potential to save seed cost productivity and



proven superiority were include seed cum fertilizer capacity reduced tillage drill, till plant machines, multicrop threshers and machineries proved their of operation and increased profitability. Women

friendly tools and equipments were also introduced to reduced the drudgery and activities like post harvest, grain processing, value addition to fruits and vegetables, chips making etc.In all 1 CAT were conducted for 30 farmers of Sehore. The Exposure visit is sponsored by NATIONAL Bank for Agriculture & Rural Development, Madhya Pradesh Regional office.

11. Awareness Programme on "Integrated Approach for Climate change by utilizing Biomass and social up-liftment to protect environment, land & forest degradation with livelihood enhancement Factor.

Science & Technology(S&T) has established its viability in terms of products, process and development models which have tremendous potential to address the problems of the rural poor. The SVSS has been implementing the project on the above mentioned title with the

support from Madhya Technology, GOMP. The implementing these societal involve S&T field groups people's participation at implementation. SVSS has set up demonstration machine along with



Pradesh Science & approach taken. while programmes, has been to with a view to ensure stages of planning and coordinated programmes models briquetting charcoal making drums

along with capacity building of 712 beneficiaries in five villages of Sehore district.

The scarcity of fuel for domestic or commercial use in rural areas has become a chronic and severe problem today. People, especially women, have spent several hours collecting firewood from distant and often dangerous locations. This is also causing server depletion of forests and tree resources. To a large segment of the rural poor, fossil fuels like coal and kerosene are out of reach, apart from the fact that their reserves are fast dwindling.

A few technologies are available for their efficient utilization as fuel, prominent among these

being converting the then convert into briquettes machine. Drum-bed fuel after pyrolysis and briquetting of without binders taking present. Conversion of briquettes would not only



biomass into charcoal and through briquetting combustion, briquetting of addition of binders and forestry/agricultural waste advantage of the lignin biomass into charcoal benefit users but would also

generate employment in rural areas. It can also be utilized to contain invasive weeds like lantana, which have a high calorific value.

The principle of briquetting consists of applying pressure to small pieces of char particles and compacting them. The briquetting could be solid pieces or in the form of hollow cylinders, binders are substances such as molasses, starch, clay, resin, lime, cow dung etc. which are used to bind particles of the primary material. The qualities of good binders include good binding ability, low cost, good smell, while burning, ready availability etc. In addition to that fuel efficient stoves was introduced which is developed & tested by ICAR and distributed among the villagers.

Use of briquettes for domestic purposes increases efficiency of use about 30-40% above the 9-15% of wood. The briquettes also prevent the problem of smoke and are hygienic and less

energy intensive. The calorific values of briquettes of this biomass are equivalent to Grade B and Grade C coal.

12. Mainstreaming of Drop out Girls from School into formal education System in Sehore District

SVSS has been working towards bringing back drop out girls from schools into formal education system with the support of District Education Dept. 32 girls were identified in the selected villages of Sehore district by a quick survey in the area. The vision of the intervention is to empower girls by providing them access to quality education and opportunities for self development. These girls dropped out either because of in examination or having failed, due to social factors or due to distance of the school. Supporting these primary and middle school dropouts will ensure their joining the mainstream school system and it would provide continuity for the programme.

13. Vocational education & Rural Entrepreneurship Development Programme

SVSS conducted 12 weeks Entrepreneurship Development programme with focus on developing technical skills for Readymade Garments. The programme conducted in collaboration with District Urban Development authority, Sehore (DUDA), had 10 trainees who were provided inputs aimed at developing their entrepreneurial skills, knowledge and attitude. Besides being provided technical skills on new design, cutting, embroidery, the trainees were provided inputs on business plan formulation, entrepreneurial skills, marketing management, interpersonal skills etc. Linkages have also been developed with local agents of readymade garments manufacturers for recognizing the trainees as skilled worker. The trainees also availed loans from the self-help groups promoted by SVSS for purchasing tool kits.

SVSS firmly believes that economic prosperity is one of the primary catalysts of improvement in quality and standard of living in both urban & rural areas. And for achieving economic prosperity in the present economic scenario where the rural masses are facing decrease in landholding, lack of jobs by the government and their inability in facing decrease the competition from urban masses for getting Jobs in private sector, SVSS has adopted an approach for motivating the communities converting themselves from job seekers to job providers. With this objective, the organization has identified and implemented promotion of need based and market driven vocational training on Sewing, Embroidery, Knitting & artificial Jewelry making as its core activities in Bhopal. The project trained 52 trainees & helped women to think for themselves and learn to make their own choices. Women in thousands who have been economically or socially empowered through the intervention of the project have helped make improvements in their standard of living and command new

respects in their communities. The skills development centre and literacy centers as well as the Mahila mandals formed by the women in their villages have carried forward the agenda of gender equity. Women have been encouraged to question the social belief and stand up for their rights, at the same time; they are also being motivated to become active decision makers within homes and communities.
